Developed from a water based concentrate, it can be diluted with up to 3 parts water, making it highly cost effective. **Wood Armour** is available in five appealing wood colors.

### APPLICATION DATA

### SURFACE PREPARATION:

- Before use, thoroughly test this product on a sample to assure performance and appearance.
- Surface must be completely clean and dry to the touch.
- Cover all plants, trees, grasses and shrubs to protect from overspray. Mask any areas that may be affected by overspray. If overspray occurs, rinse with water.
  - New Wood: Wood Armour can be applied to new and pressure treated wood within 2 to 3 weeks to reduce wood splitting, shrinkage, and greying.
  - Old Wood: If wood is weathered grey or covered with algae or mildew, renew and prepare with White Mountain Wood Cleaner, following instructions on the label. Old paint or coatings should be removed and pressure washed.
- Allow wood to dry for at least 24 hours before application.
- Water Penetration Test: Sprinkle a few drops of water on wood to be sealed. If water is quickly absorbed, wood is ready for application. If water beads or sits on surface, additional preparation is needed.

### MIXING:

- In a clean plastic or metal container, mix three parts water with one part Wood Armour concentrate.
- Dry or porous wood may require two parts water to one part Wood Armour concentrate for better protection.
- STIR WELL BEFORE AND DURING USE.
- For contractors using large mechanical mixers, mix at low speed to avoid foaming.
- When using more than one container, compare lot numbers. If lot numbers differ, mix all containers together and stir thoroughly for color consistency before mixing and application.

### APPLICATION:

**Wood Armour** can be applied using brush, pad, roller, or low pressure spray equipment.

For small areas, use an appropriate handheld sprayer to apply all coatings. Consult your local equipment supplier for recommendations. Do not allow coating to dry on spray tip. If this occurs, soak the tip in the recommended cleanup solvent.

- Apply one even, liberal coat to wood surface, paying special attention to exposed edges, joints, and sides of lumber
- Avoid runs. Wood Armour may be back brushed or back rolled for best appearance.
- If a second coat is required, apply before first coat is dry.

### Application Caution:

Cover all plants, trees, grasses, and shrubs to protect from overspray. If overspray occurs, wash off with water immediately. Mask areas that may be affected by overspray.
